THE DANGERS OF VACCINATION.

Seven Points for Anti-vivisectionists.

All anti-vivisectionists who intelligently grasp the principles of their faith are opposed to vaccination on seven solid grounds:

- 1. Because vaccine lymph is obtained by means of a cruel process consisting in the raising of numerous sores by artificial means upon the abdomen of a calf. This is an act of vivisection, though it does not come within the scope of the Cruelty to Animals Act, because it is said to have passed beyond the stage of "an experiment" into that of recognised practice.
- 2. Because the whole modern system of serum-therapy, declared, by no less an authority than Sir Almroth Wright, to be the means of introducing into the human body poisons of a virulent and disease-fostering nature, and which necessitates experiments on animals at every stage of its evolution, is founded upon the vaccination theory. In short, the vivisection of animals, as practised in the manufacture of calf lymph, was the precursor of the modern experimentation on human beings.
- 3. Because a genuine anti-vivisectionist demands justice for the brute creation as for the human, and denies the right of anyone, whether under the claim of science or of medicine, to torture a lower animal for the alleged benefit of another in a higher scale of life.
- 4. Because true anti-vivisectionists aim at the high ideals of purity, honour, sympathy and truth, and all these qualities are set at nought in the practices of vaccination and inoculation. For instance:
 - (a) <u>Purity</u>. To introduce into the healthy human body impurities which have been cast out from an animal or from another human body, no matter on what grounds or with what hopes or promises it may be done, is an impure act.
 - (b) <u>Honour</u>. To claim that these impure and disease producing methods will result in the safeguarding of the human body against disease, in spite of all the undeniable evidence to the contrary, is conduct as dishonourable as that which would profess to make a child truthful by teaching it to lie.

- (c) Sympathy. To perpetrate or to support wholesale cruelties upon animals, whether in the manufacture of calf lymph or in the experiments associated with the evolving and preparation of every kind of serum and vaccine, displays a lack of sympathy with the sufferings of speechless and inoffensive creatures that is repugnant to the feelings of true manhood and opposed to every manly and womanly virtue.
- (d) <u>Truth</u>. The whole system of vaccination is founded upon, built up and established in falsehood. Every statement, without exception, made by the founder of vaccination, accepted by Parliament, and by which the tyranny of the Vaccination Acts came into being, was a lie. The whole system since that day, in every detail of its working, has been a system of falsehood, corruption, evasion, bribery and intrigue, from which the truth has been utterly banished.
- 5. Because genuine anti-vivisectionists believe that the true prevention of disease consists in cultivating a healthy body and a healthy environment, and they loathe a system like that of vaccination, which in effect declares that if a human body be brought into a morbid condition by a species of blood poisoning with effete materials, an insanitary environment is of no consequence.
- 6. Because all true anti-vivisectionists are of opinion that science is but another name for knowledge, and that knowledge, if of force and value, must be consistent with common sense. They see in vaccination and all its progeny a system based only upon superstition and ignorance, and every attempt that has been made for more than a century to raise it to the level of scientific dignity has ended in grotesque failure.
- 7. Because no medical system that has been invented since the world's foundation has been productive of such dangerous consequences and such disease and death-dealing results, as can be laid to the charge of vaccination and its allies.

WHAT VACCINE LYMPTH IS AND DOES.

And what is the material, pray, from which vaccine lymph is manufactured? As a matter of fact nobody knows. It is such a conglomeration of filth, recording in the course of its genealogical descent alliances with horse-grease, cow-pox, small-pox, and several other poxes, that not all the combined wisdom of the

Front Bench of the House of Commons, nor all the power and intelligence of the great medical bureaucracy behind it, could answer the question of Sir William Collins in the House of Commons, "What is the origin of the vaccine lymph at present in use by the Local Government Board?"

But there is one point about which there is no doubt and it is this: That whether it be the old "Vaccine Lymph" cultivated from arm to arm, or the modern "Pure Glycerinated Calf Lymph" (which consists of matter scraped from the artificially raised sores on calves' abdomens, mixed with glycerine), the results of its use in numerous instance, as told at coroners' inquests and in medical certificates, have been - <u>Disease</u> and <u>Death</u>. And the sores which have been produced in vaccinated persons in thousands of instances - I have seen many myself - have been chancres pure and simple, which no expert syphilographer could distinguish from syphilis.

The respectable "scientific" theory held in official quarters is that cow-pox is small-pox of the cow - "a modified form of small-pox." No one with the least experience of the matter - and very few medical men of to-day have had any experience in regard to it - could honestly make this statement. The only disease to which cow-pox bears any analogy in its manifestations, is that of syphilis, and in this fact lies material for very serious thought concerning the undermining of the constitutions of those who submit themselves or their children to this ghastly and irrational operation.
