IN CROYDON AGAIN?

(or in *YOUR* Town or Borough?)

In the House of Commons on the 14th February 1962, an M.P. attempted to bring in a Bill to make smallpox vaccination compulsory for children under six months old. The motion for leave to introduce was defeated by a large majority on a division, but no less than 77 M.P.s had voted in favour of compulsory vaccination for babies. It is very evident that these M.P.s had not documented themselves on the facts concerning the shocking dangers and after-effects of vaccination. More important, it is not merely a question of enforced vaccination as such, **this being the "thin end" to extinguish medical liberty, particularly in regard to travel abroad.** Do you value your liberty? If so, join the League and preserve it while there is time.

A STARTLING FACT!

In the 25 years ended December 1962 nearly two-thirds of the children born in England and Wales remained unvaccinated for smallpox, yet only four children under 5 died from smallpox; while of the one-third vaccinated, no less than 86 children under 5 were killed by vaccination, and many more were seriously injured by it.

ENFORCING THE VACCINATION LAWS

The Clerk to the Croydon Magistrates stated that over 2,000 Vaccination Summonses had been applied for in Croydon. Six distress sales and attempted sales had been held involving hundreds of cases of fines and costs. About fifty Croydon fathers went to prison rather than have their children vaccinated or pay monetary penalties imposed.
